

## OFFICIAL COMPLAINT

Detailed, pertinent evidence; including tape-recordings, eye and ear witness accounts, and documentation available in due course or upon request.

1. Rex L. Reed did knowingly and deliberately commit criminal misconduct via abuse of power as presiding judge before, during, and after divorce proceedings against the above named.
2. Although the petitioner's stepfather; Terry R. West, was a long-time personal friend of Reeds, Reed elected to preside over the case anyway, instead of dismissing himself as required by law.
3. Reed and Mr. West continued the fa• a de of "not knowing each other" throughout all of the months of litigation and testimony, during which time Mr. West was allowed by Reed to give repeated slanderous testimony against the respondent.
4. Reed and Mr. West were secretly communicating with each other throughout the course of the entire divorce proceedings.

8. Mr. West also bragged to the children of the "power" he had over Judge Reed, claiming that if they didn't cooperate in what he was trying to accomplish, then he had the "power" to have them sent to separate foster homes out of state, and they would never see their father again.

{The children refused to be placed in their mother's custody, which was infuriating Terry West.}

9. Despite being old enough to make their own choice of which parent they wished to reside; and going completely against the C.A.S.A. recommendations, Rex L. Reed without cause or reason, forced those children against their wishes and best interests, to be placed in the custody of their mother. This was undoubtedly done so he would have a "justifiable reason" to also give her the home and all of the property, along with the respondent's mother's estate who had recently passed away. {Yes, he awarded her my recently deceased mother's estate.}

#### In Retrospect

All information contained herein is not only the truth; it's a very easily proven truth. I have detailed files, tape-recordings, documents, depositions, and eye and ear witnesses, and I've even written a novel on the nonsense.

I've spent the past eight years living my life being angry over what Reed did to my children and me. The pain, suffering, and mental anguish that man created for my children and myself is immeasurable; and the long term effects over eight years later are still horrific. I don't know how a price can be put on something like a life, but Judge Rex L. Reed absolutely destroyed all of our lives through his corrupt and illegal activities.

My wife's entire divorce case revolved directly around the "abuse excuse." Although she'd never been abused by me; or anyone else for that matter in the nineteen years we were married, Reed allowed her to pull off the perfect crime inside his kangaroo courtroom. It was the most humiliating experience I'd ever been through in my life.

In a nutshell; she had a boyfriend and wanted me gone. So, she came up with the "abuse excuse" so she could get rid of me and make room for the new guy. Reed helped her.

After Reed threw me into the streets homeless on July 15th, 1999, guys began showing up that very week for dates with my newly estranged wife, and she immediately began leaving the children at home alone and going out to the bars with these guys. This was during Reed's so-called "temporary period" where all parties were warned to behave themselves, or a reversal ruling would be handed down, putting me back inside the marital residence with my children.

This "immediately going out on dates" after claiming to have been abused for twenty years was reportedly to Reed via my attorney, and Reed ignored it.

Exactly thirty days after being thrown into the streets by Reed, a guy seemed to be not only dating the poor "damsel in distress," but instead seemed to be living in the marital residence. He was always there; answering the door and phone as though he was the man of the house.
