### Crimes:

Violation of the Constitution, federal and Indiana laws, fraud against the Elliott family and US government, official misconduct, public corruption, conspiracy to kidnap children, Child Endangerment, coercion, blackmail, conspiracy to perpetrate fraud, deprivation of rights including Fifth Amendment, Fourteenth Amendment, due process, access to the courts (Seventh Amendment), falsification of official documents for profit and defrauding the government for incentive kickbacks and payments, Child Abuse, perjury, obstruction of justice, criminal misconduct, ... .

I, Diana Elliott and Daughter Jessica Elliott are filing these complaints against the state of Indiana, its agencies and people involved. This case has involved four County Child Services aided and abetted by the state of Indiana and its circuit court. All of the said agencies have retaliated against this family for fighting for the return of our family (the children) and asserting our rights under the federal constitution and laws. We as a family have been abused by the state of Indiana and its agencies involved. I wrote a letter to Governor Kernan in 2004 with no response from his office. I wrote numerous letters and emails to Governor Daniels pleading for his help to have someone investigate this case to prevent further endangerment to the minor children involved as a result of the Indiana official and judicial misconduct and corruption.

We as a family have been stripped of our civil and constitutional rights with no one to turn to. No one would listen or help this families cries for help. I tried to get this printed in the news papers only to be told they did not want to be sued.

I wrote a letter to Senator Evan Bayh pleading for his help on this case he responded “In an effort to see that your concerns are met, I have contacted Division of Family and Children officials to request their review of this matter”. I and this family had no response from Child Services regarding this letter to Mr. Bayh.

I reported several people associated with this case and Child Services to the Attorney General Steve Carter.

Evidently, there is a conspiracy by the state of Indiana to cover up the perpetrated official and judicial corruption and misconduct.

We as a family have tried to defend our rights and been abused for speaking up for our rights. The children were abused through official and judicial corrupt system in Indiana and their rights taken from them by the state.

We as a family have had to fight a battle that should have never happened to any human being and we as a family deserve to have these people answer for their crimes in this and other cases and for the three years of not seeing our children. No contact at all. We the family are seeking justice for our abuse and the children's. We have evidence (video and audio) which would be available on request.

We are asking that you as a federal agency charged with (and duty bound by federal statutes, 18 USC §§ 2,4 Misprision Of Felony, etc) investigating official and judicial misconduct and corruption, start an investigation into such corrupt activities into the public and official misconduct perpetrated by state of Indiana and its courts and agencies.
