ASSERTIONS (supported by evidence): Violations by one perpetrator or another (above):

13. Constitutional violations (including but not limited to Due Process and Equal Protection), Conspiracy; Fraud (for moneys, ...) upon the court, the United States, Indiana citizens, and the undersigned; Unlawful falsification of official court records; Threatening and intimidating self-represented parties; Criminal official / judicial misconduct and corruption; Case fixing; Discrimination on the basis of race, gender and national origin; Acting and issuing orders (*void ab initio*) as a judge without jurisdiction and without judicial authority (e.g. without required bond and/or oath of office); Ruling as a judge with conflict of interest after having been sued by a party; Violations of the US laws, Constitution and their oaths of office; Conspiracy to effect unlawful imprisonment as retaliation; Abuse and endangerment of children; Deprivation of fundamental rights; Lying and making false representation and misrepresentations to justify unlawful orders; Conspiracy to obstruct and pervert the course of justice (e.g. *Ex parte*, secret communications to cover up fraud); Nepotism; Destruction of the undersigned's and his children's livelihood, family life, “liberty and pursuit of happiness”; Treason against the United States.
