Violations of: The United States and Indiana Constitutions and laws and  
people's fundamental rights under same;

Perpetrated by: Indiana judges at all levels up to and including Indiana Supreme Court

Judge Shepard

The State of Indiana should not be in the business of destroying children's lives for profit. Yet, the judges whom you are responsible to oversee, county prosecutors, private attorneys and Child Protective Services all engage in actions which result in just that, so the state, courts and counties can receive federal incentive payments<sup>1</sup>. Although it is well documented that children do best when raised by both biological parents, the federal government pays states to take children away from their families and place them for adoption or into foster care. Indiana is also paid to remove one divorced parent from a child's life and issue "child support" payment orders, payable through the courts, just so they can get more incentive money. It is well known that direct payments to

"the Title IV-D agency shall provide incentive payments to counties for enforcing and collecting the support rights that have been assigned to the state. The incentive payments shall be made by the Title IV-D agency directly to the county and deposited in the county treasury for distribution on a quarterly basis and in the following manner:  
(1) Twenty-two and two-tenths percent (22.2%) of the incentive payments shall be distributed to the county general fund.  
(2) Thirty-three and four-tenths percent (33.4%) of the incentive payments shall be distributed to the operating budget of the prosecuting attorney.  
(3) Twenty-two and two-tenths percent (22.2%) of the incentive payments shall be distributed to the operating budget of the circuit court clerk.

the other parent or direct and actual support<sup>2</sup> of the child won't be counted as the federal government considers only payments collected through the courts to be "support enforcement". This demonstrates the court's ulterior motives in "sole custody" arrangements with support orders, even where a situation may equitably not call for one. This, in effect, makes every taxpayer in Indiana a "child support" payer.

The undersigned, on behalf of themselves and a large number of other Indiana victims are hereby informing you, yet again<sup>3</sup>, of the knowing, deliberate and egregious instances of judicial corruption and rights violations<sup>4</sup> perpetrated under the color of law by Indiana judges<sup>5</sup> at all levels of the judicial system including County Superior and Circuit courts, the Indiana Court of Appeals and the Supreme Court. In many such instances the said corruption and deprivations lead to unlawful incarceration of innocent and good parents (extortion by the courts).

The said atrocities take place particularly in "family" courts throughout Indiana by judges, in conjunction with others (see above) to destroy families' and children's lives by depriving the children of the care and love that can and should be provided by both (fit) biological, divorced parents. Additionally, all concerned parties are systematically deprived of their family life which is held by the US Supreme Court to be the most fundamental liberty. Such destruction is motivated by the desire of said courts (and prosecutors' offices) to monetarily benefit from creating "custodial" -v- "non-custodial" parent status and hence, contrived "child support" enforcement that brings into the coffers of the courts, state and counties, millions of dollars in federal incentives. Not only do Indiana judges make such decisions in direct conflict of

interest, but in so doing they knowingly and deliberately resort to conspiracy with others to commit fraud, rule without jurisdiction and due process, issue unlawful orders and falsify official court records to cover up same. And when such violations are brought to the attention of the Indiana Court of Appeals and the Supreme Court, these two courts knowingly ignore, and/or actively cover up and/or aid and abet such lower courts' violations of the federal and Indiana laws and people's guaranteed fundamental rights under the United States and Indiana Constitutions.

The taxpayers and victims of Indiana judicial corruption, demand action by you, directly responsible for the professional conduct of Indiana judges, as follows:

1. A genuine investigation (not by or through the discredited, tainted and secretive Indiana Commission for Judicial Qualifications, but) by a credible body into the unlawful activities of and misconduct by Indiana judges.
2. A de novo review of ALL cases in which judicial misconduct and unlawful activity by judges presiding over corresponding cases can be reasonably shown or has been alleged.
3. That the Indiana Supreme Court abolish its policy or practice of ignoring and/or aiding and abetting the lower courts' violations and misconduct through ignoring Petitions For Transfer or the misconduct of the lower court judges.
4. Compel the application of the Constitutions and laws of the United States and Indiana in all state courts.

N.B. Although documentation of the said violations may have been previously provided to you, they, along with others known to the undersigned, may be available upon your request.

We thank you in anticipation and look forward to your speedy response and action.
