

Procedure for filing complaints on the web against judicial corruption

Hello,

Due to further interest expressed, additional information is hereby provided regarding the procedure to file documentation of judicial misconduct and unlawful activities in individual cases. For Nuremberg-style and other types of investigation into the corrupt judiciary, the JUSTITIA group is dedicating the web site below as a repository for VERIFIED complaints of misconduct and unlawful activities by the judiciary, especially in "family" courts, and other officials any where in the United States. We are determined to have, and demand that, investigations instituted and other constitutional actions taken against such corrupt judiciary and officials by appropriate national and international bodies.

What sets this repository apart from others are:

A) Each complaint MUST be supported by a short electronically signed affidavit which will be placed on the web.

B) Each complaint is supported by evidentiary documentation placed on the web.

C) Complaint maybe placed on the web anonymously or with the Complainant's name included. Either way, the affidavit HAS TO be signed and submitted electronically. (If anonymity is requested, the Complainant's name will be removed before placement on the web.)

D) The Perpetrators' (judge's, CPS worker's, etc) names are included in the affidavit.

E) Each complaint will be added to others and periodically submitted to relevant federal and international (including but not limited to legislative, law enforcement, overseeing) bodies to bring pressure to bear for investigation into judicial corruption within the state and federal courts and agencies in the United States.

F) The aim is to compile and maintain a body of such solid evidence that no miscreant judge or official can wriggle out of the consequence of their actions. Remember, ALL the laws that we require in our efforts, are already on the statutes or in the Constitutions. What we need is people with courage of their convictions to stop whining and wasting time on "feel-good" and ineffective programs, and instead making the violations in their cases part of the record and actively go (with us) after these crooked judges and officials.

G) Added advantage that one could direct anyone person and/or organization to one's case on this web site, hence exposing the corruption in your case easily, without mailing hard copies, and quickly.

The Procedure:

1- Each Complainant to fill out a short (no more than 2 or 3 pages- this is only an overview document) affidavit (see template "federal affidavit" on the web site below) electronically.

2- A more detailed signed complaint maybe filed in addition and placed on the web.

3- Documentary, audio and/or video evidence to be provided and placed on the web.

4- Statements in the affidavit must be confined to facts supported by evidence.

5- State whether you wish your case posted anonymously or with Complainant's (your?)

name viewable. (Either way you'd need to sign and send to me the affidavit electronically - see template).

- PROJECTS ("What YOU Could DO"): There are also other projects (see "What YOU Could Do" at the web site below) that are suggested (such as IMPEACHMENT of corrupt judges and officials as well as the "Hague Petition Project" regarding spread of Title IV-D fraud, and hence making it more difficult to change that evil statute here in the United States. To stop it from spreading and becoming more difficult to change, Title IV-D must be revoked / modified now before it becomes impossible to change.
